FOREWORD

This report chronicles the accomplishments and progress of the Regional Computer Forensics Laboratory (RCFL) Program for Fiscal Year 2013 (FY13), which covers the period from October 1, 2012, to September 30, 2013.



FY13 marked the fourteenth year of operations for the RCFL Program, with 16 laboratories operating nationwide. On

November 2, 2012, the RCFL Program opened its first transitional laboratory in Topeka, Kansas. This laboratory expands the digital forensics service infrastructure in the state of Kansas. Initially managed as part of the RCFL program, the Topeka Lab will transition to full state of Kansas control after a start-up and training period.

With 16 RCFLs and one transitional RCFL open for business, the program's focus remains one of maintaining operations in a challenging fiscal environment, while providing the highest quality digital forensics services and training to the law enforcement community. Although Federal budget cuts from sequestration impacted our program, the RCFL laboratory directors and their teams worked hard to minimize the impact. Also, this year, we were able to continue the tradition of providing an annual webinar that reaches thousands of participants, by broadcasting an event about a new and evolving technology, social media and its role in digital evidence.

As always, we extend our thanks and appreciation to the participating agencies that make up the RCFL Program and for the continued support of the FBI. In particular, we thank outgoing FBI Director Mueller, who was a program supporter, and welcome new FBI Director Comey. It is only through partnerships that our program can continue to thrive in strengthening law enforcement's digital forensics capacity. We look forward to building on our past successes while exploring new ways to strengthen law enforcement's digital forensics capabilities in the neighborhoods where we work and live.

1.0 INTRODUCTION

This document highlights the Regional Computer Forensics Laboratory (RCFL) Program's accomplishments in fiscal year 2013 (FY13), which covers the period October 1, 2012 to September 30, 2013.

An RCFL is a full-service digital forensics laboratory and training center devoted entirely to the impartial analysis of digital evidence in support of criminal or national security investigations. It is a cooperative arrangement between the Federal Bureau of Investigation (FBI) and other law enforcement agencies of federal, state, and local governments operating within a limited and specific geographic area. There are 16 RCFLs in the National Program.

Services

RCFL services include -

- > Pre-seizure consultation and onsite seizure collection
- Duplication, storage, and preservation of computers and computer-related evidence
- Prompt, accurate, and impartial forensic examinations of digitally stored media
- > Consultation on digital forensic matters
- Courtroom testimony.

Highly-trained examiners can address most types of digital evidence, including computers, cellular telephones, tablets, Global Positioning System (GPS) devices, and loose media. A growing number of laboratories also have video and audio capabilities. Self-service kiosks are now available at all RCFLs, allowing investigators to preview seized cell phones, smart phones, and loose media, which has provided faster results to investigators and reduced backlog at the labs. Work is performed at the highest level of quality. Thirteen RCFLs are accredited by the American Society of Crime Laboratory Directors/Laboratory Accreditation Board (ASCLD/LAB), either in its Legacy Program or in the ASCLAD/LAB-International Program using the newer International Organization for Standardization (ISO) certification process.

Oversight

Each RCFL is overseen by two entities:

- The RCFL National Program Office (NPO), an FBI component established in 2002 to manage and oversee the national program. It manages the program funding, provides the equipment, and supports the communications, training, facilities, and information technology needs of the RCFLs.
- The Local Executive Board (LEB) comprised of executives from the law enforcement agencies that participate in a specific RCFL. Participating agencies have one or more of their personnel working at an RCFL. Members of this board advise on the operations and oversight of an RCFL.

Participation

An RCFL is a partnership between the FBI and other law enforcement agencies operating within a geographic region. Organizations that enter into a Memorandum of Understanding with the FBI become participating agencies in the RCFL. In this capacity, they detail their staff to work in the laboratory, and in return, they and their personnel receive the following:

- > Access to digital forensics examination and advisory services.
- > Seven weeks of sophisticated technical training.
- Compensation of overtime worked paid through Asset Forfeiture Funding.
- **>** Broad experience in a variety of digital forensics disciplines.

RCFL detailees receive the same training and certification that is provided to the FBI's Computer Analysis Response Team (CART). Many RCFL examiners cite the opportunity to obtain the prestigious CART certification and follow-on training as one of the greatest benefits of joining the program. The FBI invests \$15,700 in their first year, \$12,800 in the second year, and \$5,000 each subsequent year, per new examiner.



2.0 PARTNERSHIP

Participating Agencies

RCFL staff members are detailed from 130 participating agencies. The executives of these agencies serve on the LEBs of each of the RCFLs. The program could not operate without this generous support.

FBI Digital Forensics and Analysis Section (DFAS) Components

The RCFL Program could not be successful without leveraging programmatic, technical and training innovations and support from other FBI DFAS components:

- Forensic Analysis Unit (FAU)—which manages the Cell Phone Investigative Kiosk (CPIK), Loose Media Kiosk (LMK), and Mobile Lab programs, develops the ImageScan and DriveQuest preview tools, manages the CAIR program, manages the program that provides the forensic network, and provides program management for specialized examiner certifications.
- Forensic Operations Unit (FOU)—which manages the database that RCFLs use to capture performance statistics and coordinates on large case support. FOU also coordinates the training and certification program that all RCFL examiners must successfully complete.
- Forensic Support Unit (FSU)—which manages the program to test and validate the tools used at RCFLs, coordinates the Digital Evidence Laboratory quality assurance program, and supports RCFL efforts to prepare for accreditation.
- Cryptologic and Electronic Analysis Unit (CEAU) which examines evidence submitted by the RCFLs that is technically challenging often involving encrypted or protected data on digital media. CEAU has also provided advanced training to several RCFL examiners to help expand field capabilities. This year CEAU provided substantial and invaluable support to the Social Media and Digital Evidence webinar.
- Forensic Audio/Video and Image Analysis Unit (FAVIAU)—which supports RCFLs by providing training on video and image analysis and by providing examination services and testimony for technically challenging cases.
- Investigative Analysis Unit (IAU)—which conducts complex digital analysis using advanced innovative techniques and technologies.
- Digital Analysis and Research Center (DARC)—which provides investigative capabilities and support to the FBI's Violent Crimes Against Children Program aimed at combating child sexual exploitation.

3.0 FY13 PROGRAM ACCOMPLISHMENTS

Despite substantial budget cuts faced by the RCFL program in FY13, dedicated teams at the 16 RCFLs continued to examine thousands of terabytes of evidence and achieved several important milestones.

- The value of the self-service kiosks was proven again this year. Area law enforcement officers use the kiosks to preview cell phones, smart phones, and many types of loose media. More than 15,000 of these devices were previewed in FY13, or, on average, 57 each workday. The availability of these tools is a win/win-investigators retrieve data more quickly and the work is done in a forensically sound way; highly-trained RCFL examiners can focus their efforts on more complex examinations.
- > RCFLs continue to process thousands of terabytes of data each year-in FY13 5,973-despite the increased kiosk use.
- The program's first transitional laboratory in Topeka, Kansas opened thanks to the combined efforts of the Heart of America RCFL, the FBI, the Kansas Bureau of Investigation (KBI), Shawnee County, Kansas Sheriff's Office and Topeka, Kansas Police Department. The opening of this laboratory, which, within a few years, will transition to full KBI control, fulfills a goal envisioned when the RCFL Program was first launched and one that the National Advisory Board had advocated.
- RCFLs remained at the forefront of ensuring operations meet rigorous standards set by the scientific community. Seven RCFLs achieved ASCLD/LAB International Program accreditation this fiscal year, joining two other labs already accredited in International. Requirements are based on International Organization for Standardization (ISO) 17025-2005

- standards and ASCLD/LAB supplemental requirements. Five additional labs are scheduled for the International Program assessment in FY14. Thirteen of the 16 RCFLs had previously achieved Legacy accreditation.
- For the fifth time, the RCFL Program invited law enforcement officers from around the world to attend a digital forensics training webinar, aimed at reaching the broadest possible audience. The live, virtual event on Social Media and Digital Evidence, that was co-sponsored by the FBI's CEAU and broadcast live from the FBI Academy studio, was viewed by 1,655 participants from 45 states and 15 countries.
- RCFLs were called to support important cases both inside and outside their service areas. For example, staff from six RCFLs and the RCFL National Program Office provided a range of support to help process the flood of evidence submitted in the initial phases of Boston Marathon bombing investigation. In a time-sensitive and high-profile investigation into the murders of public officials, the North Texas RCFL's training room was converted to examination space and then review space for federal, state, and local investigators on the Digital Crime Analysis Position (DCAP) system. The OCRCFL fielded its mobile laboratory to support the manhunt for former LAPD officer Christopher Dorner.
- The program's first RCFL, San Diego, moved to its modern 12,100 square foot facility in the new San Diego FBI Field Office. The team completed the complex move, one that involved six semi tractor trailer loads of gear containing thousands of pieces of forensic equipment, furniture, disconnecting and reconnecting networks, and transferring evidence in six calendar days. The SDRCFL was closed for business for only three work days.



First Transitional Laboratory Opens

The FBI, state of Kansas, and local law enforcement officials held a press conference on November 2, 2012 to commemorate the opening of the Topeka Satellite Regional Computer Forensics Laboratory (RCFL). The new laboratory, housed at the Kansas Bureau of Investigation (KBI) Headquarters in downtown Topeka, is the first satellite facility affiliated with the Heart of America RCFL (HARCFL) in Kansas City and the first-of-its-kind transitional laboratory in the FBI's RCFL Program.

Built entirely with Kansas state funds, the Topeka Satellite RCFL is initially operating under the direction of the HARCFL. After three to five years of stewardship, the lab will transition to full state control as a KBI laboratory. The KBI and the Topeka Police Department are detailing staff to the facility, and an experienced examiner from the Shawnee County (Kansas) Sheriff's Department will be detailed from the HARCFL. The FBI provides operational funding, training, equipment, and oversight. The lab will address most types of digital evidence including computers, cell phones, tablets, GPS, and loose media.

Michael Kaste, Special Agent in Charge of the FBI's Kansas City Division, KBI Director Kirk Thompson, and Kansas Attorney General Derek Schmidt all spoke of the value of the new lab and the partnerships that were instrumental in creating it. "The ability to build on the success of an established RCFL in Kansas City and to be able to provide those services in an off-site capability affords law enforcement another powerful tool in the fight against crime,

said SAC Kaste. "The KBI was created to protect Kansans and to assist local law enforcement in that calling," said Director Kirk Thompson. "This satellite regional computer forensic facility will do precisely that—it will help meet the demand for digital forensic work in investigations across Kansas." Attorney General Derek Schmidt said. "This first-of-its-kind laboratory demonstrates the commitment and cooperation of our local, state, and federal partners in meeting the growing need for computer forensic analysis. The governor and the Kansas legislature are to be commended for supporting this critical public safety project."

FBI's Mobile Laboratories: Bringing the Power of a Digital Forensics Laboratory to the Field

The Orange County RCFL and North Texas RCFL are proud to be two of six sites nationwide to host an FBI mobile digital forensics lab or "M-LAB". The lab's purpose: to provide onsite digital forensics support to critical FBI and partner agency investigations. The M-LAB Program is sponsored and funded by the FBI's Digital Forensics and Analysis Section, as part of its ongoing efforts to provide the highest quality digital forensics support to law enforcement.

An M-LAB provides full digital forensic processing and examination capabilities "on the move" and in the field. Examiners can process, in real time, evidence found on standalone computers, computer servers, and all types of mobile computing devices such as cell phones, smart phones, tablets and loose media storage systems found during the course of a breaking investigation.

Although each of the FBI's M-LABs has custom features, the basic design is similar. A 35-foot cargo van is custom-outfitted with state-of-the-art computer workstations, an area for mobile device processing, and a high-capacity server that can be rolled out of

the M-LAB and into a real-time search site. The M-LAB server can also be connected to target computers by fiber optic cables, using a custom "on-board" generator system, and other specialized equipment.

Seven More RCFLs Attain Prestigious ASCLD/LAB International Program Accreditation

Since its inception, the RCFL
Program has maintained an
unwavering focus on quality. Before
there were accreditation programs in
the nascent computer forensics discipline, the FBI's CART program, along
with RCFLs, followed a rigorous
quality assurance program. When



ASCLD/LAB added computer forensics to its Legacy accreditation program, RCFLs began to seek accreditation. Thirteen of the sixteen laboratories sought and attained accreditation.

When ASCLD/LAB launched its International program accreditation for Digital and Multimedia Evidence, the RCFL Program set a goal of having its laboratories meet these international standards

of forensic practice that cover areas such as management, operations, personnel, procedures, equipment, physical plant, and health and safety procedures.

The accreditation process involves an intensive, external, independent review that evaluates the qualifications of all laboratory personnel; the laboratory's operational and technical policies, practices, and procedures; and the laboratory's quality management system. Accreditation is awarded for four years, but each year, ASCLD conducts annual surveillance visits and requires reporting on conformance.

- In November 2009, the North Texas RCFL was the first RCFL to attain International program accreditation.
- In May 2012, the New Jersey RCFL was accredited.
- In FY13, seven additional RCFLs-Silicon Valley, Orange County, Philadelphia, Rocky Mountain, San Diego, Heart of America, and Intermountain West- followed suit.
- > Preparation is underway for six additional labs to undergo the assessment process in FY14 and FY15.

Credit for the success of these efforts goes to the full staff at each RCFL and to the FBI DFAS Quality Manager, and the Quality Managers at each laboratory.

4.0 TRAINING IS KEY

The RCFL Program—both individual RCFLs and the RCFL National Program Office—offers a range of training and education programs for law enforcement officers, prosecutors, and this year, members of the public and the scientific community. Courses cover topics related to seizing and handling digital evidence, using FBI-developed preview tools, and understanding digital forensic examination results. RCFLs do not offer training on conducting digital forensic examinations. In FY13, these training programs included:


- In-classroom forensic courses offered to more than 3,000 law enforcement officers as a part of regularly scheduled classes hosted at state-of-the-art RCFLs.
- A first-of-its-kind education event for the RCFL Program in which the OCRCFL and FBI Los Angeles partnered with the National Academy of Sciences.
- The second digital forensics conference for prosecutors hosted by the HARCFL.
- A virtual webinar, the RCFL Program's fifth, on Social Media and Digital Forensics, and attended by more than 1,600 government participants from around the U.S. and the world.

Ongoing RCFL-Sponsored Training

Individual RCFLs offer a variety of training classes to members of their local law enforcement community. Offerings differ depending on the laboratory but generally include courses such as:

- Seizing and Handling Digital Evidence. Law enforcement officers learn how to recognize digital evidence and then how to handle it when legally seized.
- ImageScan and DriveQuest. Participants get hands-on training in using FBI-developed preview tools.
- Case Agent Investigative Review (CAIR). Law enforcement officers who have submitted evidence to the RCFL for forensic examination learn how to understand the results of the exam.

This year the Philadelphia RCFL was the most active of all RCFLs, training 914 individuals during FY13. This represented 42 percent increase over the number trained in Philadelphia the previous year. One of the unique offerings at PHRCFL is a two-day forensics overview class for probation officers, which covers a range of topics including introduction to forensics, collecting and preserving digital evidence, using the cell phone and loose media kiosks and DriveQuest training.

OCRCFL, FBI and National Academy of Sciences Event

The Orange County RCFL, in partnership with the FBI Los Angeles Division and the National Academy of Sciences (NAS), sponsored a half-day educational event entitled "Digital Forensics in the 21st Century". The goal of the program was to educate scientists and members of the public on the practice and challenges of digital forensics. The event was part of the NAS' Distinctive Voices initiative aimed at improving science literacy. It featured presentations, case studies, and hands-on demonstrations of technology and methods, by OCRCFL examiners. The state-of-the-art mobile lab (M-LAB) was on display and open for tours. More than 280 people attended the program.

HARCFL's Second Annual Prosecutor's Conference

Due to the positive feedback from last year's inaugural conference, the HARCFL once again sponsored a one-day event on digital forensics for prosecutors in FY13. The training helps fill a long-standing gap in the education of prosecutors on the significance of digital evidence and how to accurately present it during trials. Sixty participants attended the 2nd Annual Digital Forensics for Prosecutors Conference on November 2, 2012. The program included technical presentations on mobile device evidence, encryption, forensic video, as well as practice-based training on courtroom presentations and ethical issues.

Social Media and Digital Forensics Webinar

The RCFL National Program Office partnered with the FBI's Cryptologic and Electronic Analysis Unit (CEAU) to present the program's fifth webinar, "Social Media and Digital Evidence" on July 10, 2013. This two-hour, live event, was broadcast from the FBI Training Division Studio in Quantico, VA. Part of the RCFL's Continuing Education Series, the webinar program's goal is to cost-effectively address the broad, awareness-level training needs of law enforcement officers on timely issues related to digital forensics. The webinar program is one of the NPO's most impactful outreach initiatives. More than 11,000 participants have participated in the webinar program since its inception in 2007.

Topics covered in this year's webinar included:

- Overview of the role of the social media in investigations and emerging trends
- How social media artifacts are recovered (forensically with appropriate legal authority)
- > How investigators should work with forensic examiners
- Challenges—now and in the future.

On event day, 1,655 participants tuned in from around the country and around the world:

- Domestic participants from 659 different agencies in 45 states, the District of Columbia, Puerto Rico, and Guam participated.
- Officials from 15 foreign countries (Aruba, Australia, Brazil, Canada, Columbia, Cypress, Antigua and Barbados, Bosnia and Herzegovina, Netherlands Antilles, Estonia, Hong Kong, Netherlands, Portugal, Saint Lucia, and Spain) also tuned in.

Following the broadcast event, the RCFL NPO began offering a recorded version (online or DVD) of the webinar to individuals who

were unable to attend. The NPO also offers copies of the presentation slides and certificates of completion.

Topics are chosen based on recommendations from previous years' webinar participants and input from RCFL Laboratory Directors and the FBI's Digital Forensics and Analysis Section leadership. The NPO handles planning, registration, and follow up; NPO team members, FBI and RCFL subject matter experts, and webinar panel members develop the webinar content, and the FBI Training Studio handles the production.

5.0 ASSET FORFEITURE FUND

Department of Justice (DOJ) Asset Forfeiture Fund

Since 2006, the RCFL Program has received and administered Department of Justice (DOJ)—Asset Forfeiture Funds (AFF). In FY13, Program funding was \$2.2M.

The RCFL Program's highly valuable partnership with the Asset Forfeiture and Seized Property Unit, which allows the program to receive Asset Forfeiture Funds (AFF), remained on track and productive during FY13. As municipalities grapple with budget cuts, AFF resources make it possible for some state and local law enforcement agencies to continue their affiliation with the RCFL Program.

AFF resources were applied toward the following activities, contributing to our continued success and productivity this year.

- **Backlog Reduction**—thirteen of the 16 RCFLs reduced their backlogs during FY13. An RCFL places a service request in backlog if it has been open more than 30 days and is not closed within 60 days. Because of the availability of AFF resources, the RCFL program can compensate Examiners detailed from state and local law enforcement agencies for any overtime worked—enhancing productivity across the board.
- Overtime Compensation—the RCFL NPO processed 4,226 requests for overtime using AFF resources. Being able to offer overtime compensation to our state/local partners is an important benefit associated with joining the RCFL program.
- Leased Motor Vehicles—the RCFL NPO provided 110 leased motor vehicles to state and local examiners during the FY13. Personnel participated in 603 onsite operations. Having a leased vehicle at their disposal enables personnel to quickly respond to last-minute and/or emergency requests for digital forensics support (e.g., a missing child or terrorism investigation).
- > **Equipment Purchases**—RCFL personnel must have access to the latest tools, technologies, hardware, and software to conduct examinations of digital devices, in addition to having the proper resources to examine earlier models.

- During FY13, the RCFL staff collectively examined 31,254 pieces of media, such as laptop computers, cellular telephones, tablets, and gaming devices.
- Issued Cellular Telephones—the program issued 80 cellular telephones to state and local personnel assigned to RCFLs.

Putting AFF Resources to Work In the Field

AFF resources help make support to these types of cases possible:

- **Guilty Pleas in Gang Racketeering Case.** Multiple members of the Aryan Brotherhood of Texas (ABT), a large, organized, whites-only gang operating inside and outside of prisons, pleaded guilty to racketeering charges. According to court documents, ABT gang members and associates agreed to commit multiple acts of murder, robbery, arson, kidnapping and narcotics trafficking on behalf of the gang. Glen Ray Millican, Justin Christopher Northrup, Samantha Goldman, Benjamin Troy Johnson and Charles Lee Roberts, along with other members, each pleaded guilty to one count of conspiracy to participate in racketeering activity. Each faces a maximum penalty of life in prison. A total of 36 defendants have been charged in one of the largest racketeering cases brought by the Department of Justice in recent years. The GHRCFL performed forensic examinations on the computers of the accused.
- RCFL provided critical assistance to law enforcement agencies during the high-profile manhunt for Christopher Dorner, a former Los Angeles Police Department officer, who was suspected of killing the daughter of a former LAPD captain and her fiancé and two police officers. OCRCFL examiners assisted the LAPD and Irvine Police Departments in the serving of a search warrant at Dorner's home and in seizing and analyzing computers and cell phones in support of the investigation. The OCRCFL mobile lab was also used to support the investigation. Dorner, who eluded police for 9 days, died in a Big Bear cabin in the San Bernardino Mountains, during a standoff with police.

"CRAIGSLIST RAPIST" CASE: Charles Oliver, 44, of Woodstock, III., faced multiple rape charges for allegedly attacking several women who responded to his online Craigslist ads for paid sexual encounters. The attacks took place from November 2011 through early 2013. The women allegedly answered ads but were then tied up, taunted, photographed or videotaped and some were physically assaulted. Police found thousands of images and videos of women engaged in sexual acts with Oliver, according to Prosecutor Sharyl Eisenstein, "Some [of the encounters] appear consensual, but many appear forced." Oliver sometimes saved the victims' driver's licenses and other souvenirs from the encounters and would later call to threaten the women if they alerted the police. Oliver was sentenced to 36 years in prison. The Chicago RCFL assisted the Woodstock, Illinois Police Department in this case by examining the digital media evidence seized from Oliver's home. The digital media processed led to the identification of more than two dozen potential victims.

CHILD MURDER CASE: A 22-year-old Maywood woman and her boyfriend were charged in April 2013 with beating and killing her 1-year-old son and then disposing of his body in a book bag in the Des Plaines river. Lakeshia Baker, 22 and Michael Scott, 21, allegedly beat Bryeon Hunter with a belt and plastic hangers and left him to die on their bathroom floor, prosecutors said in court. The couple then allegedly devised an elaborate plan to cover up the murder. They reported to authorities that the child had been abducted. Baker reiterated the abduction story on live television. Police issued an Amber Alert and searched abandoned buildings, dumpsters and industrial areas looking for Hunter. A month after the disappearance, the decomposing body of a child was found on the bank of the Des Plaines river. In September 2013, after extensive DNA testing, authorities confirmed the body as Hunter's. According to prosecutors, Baker and Scott confessed to the murder and provided details about the crime. However, both entered not guilty pleas at their arraignments in May. The Chicago RCFL processed the digital media seized during the investigation.

JOLIET MAN SENTENCED TO 62 YEARS IN CHILD SEX CASE:

Jason D. Hagerstrom was sentenced to 62 years in prison for predatory criminal sexual assault. Hagerstrom was arrested on domestic battery charges for allegedly punching a teenage girl in an argument at his residence. During the course of the investigation, it was revealed that Hagerstrom engaged in various sex acts with the victim since she was 8 years old. A cellphone seized from Hagerstrom was examined and videos of Hagerstrom and the girl were recovered.

NOTABLE NEWS

CHILD PORNOGRAPHY: Saul Ernesto Menjivar, an El Salvadorian native in the US on a work visa, was charged with three counts of possession of child pornography. He allegedly used unsecured computers in the offices he was paid to clean to search for and view child pornography. The crime



was uncovered when employees at a local business discovered images of child exploitation on company computers not secured with passwords. Review of file creation dates and times revealed that the images were accessed late at night. Examination of video from building's surveillance cameras showed a member of the contract cleaning crew accessing the business during the night time frame. GHRCFL conducted forensic examinations on the submitted computers and identified images of child exploitation. Victims were estimated to be between two and sixteen years old.

BOMB THREAT CONVICTION: Dereon Kelley, a Texas man accused of communicating a bomb threat to an academic institution, was found guilty in federal court and was sentenced in May 2013 to 33 months in prison. Evidence and court testimony showed that Kelley, using his cell phone, hacked into his former

Prepare for International Accreditation: The GHRCFL converted to the standards set forth in the International Organization for Standardization (ISO) requirements used by the America Society of Crime Laboratory Directors/Laboratory Accreditation Board (ASCLD/LAB). girlfriend's Yahoo e-mail account and sent three separate e-mails threatening to bomb the Admission's Office at Texas State University. The school was evacuated in response to the threat. The U.S. Attorney's Office relied heavily on the evidence obtained from the GHRCFL to obtain this conviction and commended the RCFL on its assistance. Kelley faces additional charges in Brazos County District Court for making a similar threat to Texas A&M University.

FIRST-OF-ITS-KIND TRANSITIONAL RCFL OPENS: Officials from the FBI, state of Kansas, and local law enforcement agencies commemorated the opening of the Topeka Satellite Regional Computer Forensics Laboratory (RCFL) in November 2012. The new laboratory, housed at the Kansas Bureau of Investigation (KBI) Headquarters in downtown Topeka, is the first satellite facility affiliated with the Heart of America RCFL (HARCFL) in Kansas City and the first-of-its-kind transitional laboratory in the FBI's RCFL national program. Built entirely with state funds, the Topeka Satellite RCFL is initially operating under the direction of the HARCFL. The KBI and the Topeka Police Department are detailing staff to the facility, and an experienced examiner from the Shawnee County (Kansas) Sheriff's Department is detailed from the HARCFL. The FBI is providing operational funding, training, equipment, and oversight. The new laboratory directly supports the RCFL program's goal of expanding digital forensic capability.

CELEBRATING 10th ANNIVERSARY: On July 9, 2013, FBI and state and local law enforcement officials commemorated the 10-year anniversary of the HARFCL at a ceremony held outside the laboratory's headquarters. The HARCFL, which officially opened July 9, 2003, was the fourth of the now-16 FBI-sponsored digital forensic and training centers operating the U.S. In 2003, 11 agencies participated with 14 full-time examiners. There are now 22 participating agencies and 24 full-time examiners on board. John Douglass, Chief, Overland Park Police Department and Chairman of the HARCFL Executive Board, served as emcee of the event. The gathering also provided the opportunity to celebrate another recent achievement, International Program accreditation from ASCLD/LAB.

ACHIEVED ASCLD/LAB INTERNATIONAL PROGRAM

ACCREDITATION: IWRCFL successfully completed the required ASCLD/LAB five-year re-inspection process and was recertified under the International program for another five years.

HIGH SCHOOL BOMBING PLAN: The IWRCFL provided digital forensics expertise to the investigation into a plan to bomb a Utah high school during a school assembly. Two high school students were arrested after a classmate alerted authorities about text messages received related to the plan. Investigators found maps of the school, information about the school's security surveillance cameras and an escape plan from the Ogden Hinckly Airport. One of the teens had spent hours on a flight simulator to learn to fly a plane. He had also recently visited Columbine High School to learn more about the 1999 shootings. One of the suspects, then 16, pleaded guilty to possession of a weapon of mass destruction. No bomb was found but conspiracy is an element of the possession charge. The second teen, 18, whom investigators determined had a minimal role in the plan, pleaded guilty to criminal mischief and received a 105-day jail sentence.

FBI INTERNATIONAL TERRORISM CASE: The IWRCFL provided extensive digital forensics services and expertise for a high profile IT case within the Salt Lake Division. The subject was charged with multiple charges including distribution of information relating to explosives, destructive devices, and weapons of mass destruction. Prosecution is ongoing and the IWRCFL continues to provide digital forensics support.

GUILTY PLEA IN FEDERAL PORNOGRAPHY CASE: The Kentucky

RCFL provided digital forensics assistance in the case against Philip Haering on multiple federal pornography charges. Haering pleaded



guilty in United States District Court, admitting that he used a peer-to-peer file sharing network to download images of child pornography between May 19, 2006 and May 3, 2011. A forensic examination revealed over 20,000 files of child pornography on a laptop computer, thumb drives, and hard drives. Haering faces a statutory mandatory minimum sentence of 5 years in prison. The maximum potential penalties are 110 years in prison, a fine of \$1,500,000 and a period of supervised release of at least 5 years.

GUILTY VERDICT IN SEX WITH MINOR CASE: The KRCFL assisted authorities in the case against Joseph David Martin, 39, accused of 31 felony charges related to having sex with an underage female over a three-year period. The girl was thirteen when the abuse began. Charges included complicity to tamper with physical evidence and to tamper with a witness. A jury convicted Martin on every count and sentenced him to the maximum time possible: 580 years. The judge followed the jury's sentencing recommendation; however, state law limits the maximum time served in jail to 70 years.

LETTER OF COMMENDATION: A Letter of Commendation (LOC) was presented to Forensic Examiner Kimberly Bradley. She was recognized for her "tireless efforts and contributions to the Kentucky RCFL. Ms. Bradley has been one of the most productive examiners at the KRCFL examining more than 170 devices in the previous two years. At the same time, she served as the KRCFL's Quality Assurance Manager, participated in seven Pre-ASCLD



Assessment Audits for other RCFL facilities, completed numerous training courses and attained 3 new certifications.

GUILTY IN CHILD AND INFANT PORNOGRAPHY CASE: A jury in federal court convicted James O. Napier, 38, of eleven child pornography counts involving an 11-month-old infant and 9-year-old girl. The investigation began when the FBI's Cincinnati Division received information from FBI Phoenix



alleging that Napier was advertising the sale of child pornography on a website. After further investigation, Napier was arrested and multiple computers and cell phones were seized and then analyzed by MVRCFL examiners. Testimony at the trial showed that Napier molested the infant and recorded a video of the incident, which he then offered for sale. The investigation also identified a 9-year-old victim who was also exploited and filmed. Napier was sentenced to 240 years in prison. Two examiners provided expert testimony at Napier's trial. The U.S. Attorney prosecuting the case commended the MVRCFL's assistance.

U.K. RESIDENT GUILTY IN VIOLATION OF U.S. CHILD **EXPLOITATION LAWS:** A British man, who traveled to Dayton, Ohio to engage in sex with a minor, has been jailed for 16 years by a U.S. Federal Court for child sex offenses. Richard Castle, 47, of Northampton, U.K. was extradited to the U.S. in March 2013 following an investigation by the U.S. Immigration and Customs Enforcement Agency (ICE) with support from U.K. law enforcement authorities. Castle admitted to using the internet to coerce a minor to engage in illicit sexual activity and to transferring obscene materials to the same minor. Castle posed as someone named Richard Joshua Parker, flew to Dayton in June 2011 to engage in sex with the minor, and stayed about three weeks. The MVRCFL assisted ICE and New Scotland Yard with analysis of computers and other digital devices used by the victim. This forensic analysis assisted investigators in obtaining a guilty plea from Castle.

INTERNATIONAL COOPERATION LEADS TO FEDERAL **CONVICTION IN CHILD PORNOGRAPHY CASE: The MVRCFL** supported an investigation that began when an Australian Federal Police officer working undercover on the internet was offered child pornography images. The officer identified the offerer as Richard Trepanier, 40, of Gettysburg, Ohio. Agents from the FBI Cincinnati-Dayton Residence Agency investigated and interviewed the subject. Trepanier provided consent to a search of his computers. MVRCFL forensic analysis identified approximately 56 images of child pornography and evidence that Trepanier was trading child pornography. Trepanier was convicted in a six-day trial and sentenced to 168 months in prison.

Train Replacement for Retiring Examiner: The MVRCFL welcomed a new Task Force Officer (TFO) from the Dayton Police Department. The new TFO has taken multiple training courses and is well on his way to becoming a certified forensic examiner.



Promote Kiosk Use: Usage of the LMK and CPIK more than doubled from FY12 to FY13. This increase can be attributed to outreach with local agencies and better education of officers on use of the kiosks when they are at the MVRCFL.



Install and Implement a Forensic Network: The Examiner Net system has been installed and deployed to the MVRCFL. The MVRCFL is working on getting examiners better trained in its use and in educating FBI personnel on its potential.

Increase Use of Examiner Net: FBI Cincinnati has a limited number of agents trained in Case Agent Investigative Review (CAIR). The MVRCFL forensic network has been used on a few test cases, but is not being utilized at its full potential. The MVRCFL will educate and train FBI personnel regarding CAIR and promote the use of Examiner Net.



Increase Training For Local Agencies: The MVRCFL has a knowledgeable staff of examiners, but does not have a dedicated training space. The MVRCFL will focus on expanding our training program by devoting more time to exploring the logistics of providing training outside of RCFL space.



Promote Self-Service Kiosks: The MVRCFL has had a marked increase in use of the LMK and CPIK by local agencies. However, the LMK and CPIK are under-utilized by FBI personnel. The MVRCFL plans to provide training to the Cincinnati Division on the capabilities of the lab and the use of the LMK and CPIK. Expanding usage of these tools by the FBI should allow MVRCFL examiners to focus on examinations requiring more advanced technical analysis.

25 ARRESTS FOR CHILD PORN DISTRIBUTION: The NJRCFL is assisting the New Jersey Interstate Crimes and Against Children Task Force in its latest crackdown on child pornography in the state. Multi-agency teams swept across New Jersey over 5 days in February 2013 to arrest twenty five people who are accused of downloading or distributing videos of young children being sexually molested. The defendants range in age from 17 to 66. Attorney General Jeff Chiesa said five of the men arrested had direct contact with young children, and two of them regularly acted as babysitters. The sweep was part of "Operation Ever Vigilant." Computer media seized as evidence was turned over to the NJRCFL for examination.

BOSTON BOMBING SUPPORT: During the early days of the May 2013 Boston Bombing, two examiners from the NJRCFL provided on site support to assist with video surveillance and cell phone examinations. In addition, multiple items were sent to the NJRCFL to be forensically imaged for examination. The NJRCFL remained on 24-hour call during the investigation.

HUSBAND AND WIFE GUILTY IN CHILD PORNOGRAPHY

CASE: Frederick Gonzales, 42, and his wife Carey Gonzales, 36, of Albuquerque, New Mexico, were convicted in a federally-prosecuted child pornography case. At the time of their arrests, Frederick Gonzales was the incoming president of Albuquerque's Young America Football League and Carey Gonzales was a kindergarten teacher's aide for the Albuquerque Public Schools. Frederick was sentenced to 97 months in prison. Carey, the first female convicted of child pornography-related charges in New Mexico, was sentenced to 36 months. The NMRCFL conducted an in-depth analysis of the digital media in the case and determined

that the couple had tried to hide their activities by copying downloaded files from a computer to a CD/DVD and then deleting the computer files. The analysis helped secure quilty pleas.





Frederick and Carey Gonzales Plead Guilty to Federal Child Pornography Charges

CONVICTION IN STALKING AND ATTEMPTED MURDER

CASE: Andrew Smoot, 22, received a 12-year sentence in a case that charged Smoot with trying to kill an ex-girlfriend whom he had met on the internet. A sheriff's deputy had spotted Smoot's car parked outside of the ex-girlfriend's home. It contained a bottle of lighter fluid and latex gloves, face masks, anti-freeze and a package of steaks. According to press reports, Smoot admitted that he intended to disable the family's dog with anti-freeze soaked steaks and then set fire to the house. Smoot pleaded no contest to the charges. The NMRCFL examined the subject's computer, found evidence that Smoot was accessing the victim's Facebook account and also located software that indicated Smoot was attempting to hide his online actions.

GUILTY PLEA IN CHILD PORNOGRAPHY CASE: Richard Crisman of Rio Rancho, NM, pleaded guilty to child pornography charges and received a 97-month sentence and 25 years of supervised release for his conviction. Crisman acknowledged that a forensic examination of his computers and media uncovered more than 14,000 images and 40 videos of child pornography. Crisman was arrested in Sept. 2011 as part of Operation Predator, of the New Mexico Internet Crimes Against Children (ICAC) Task Force. The New Mexico Regional Computer Forensics Lab (NMRCFL) examined evidence in this case.

CONTINUED STRONG PERFORMANCE DURING YEAR OF

CHANGE: Despite turnover of more than one-third of the team at the NTRCFL in FY13, the lab continued to provide excellent service to law enforcement agencies in the region, add a new service, and pass its annual ASCLD/LAB accreditation inspection with zero corrective actions required. The NTRCFL's Local Executive Board approved the nomination of FBI Supervisory Special Agent Allyn Lynd as Laboratory Director. The Dallas and Plano Police Departments and the FBI provided new examiner trainees for ones that had been reassigned. The NTRCFL also completed the installation of a review network that allows state and local officers to review the results of forensic examinations remotely.

MURDER OF PUBLIC OFFICIALS: The NTRCFL played multiple key roles in the murder investigations of a Kaufman County Assistant District Attorney who was gunned down while walking to the courthouse, and, in a separate incident two months later, the slayings of his supervisor, the District Attorney, and his wife in their home. NTRCFL examiners assisted in the collection and processing of the digital evidence from both crime scenes, the computers of the victims, and videos from business and residential security systems near both murder scenes and along the path believed to be used by the subject(s). Video examinations conducted by an NTRCFL examiner from the Dallas Police Department identified a subject vehicle and provided probable cause to search a storage shed and the home of a suspect. NTRCFL personnel then assisted in the seizure of computers and digital media and processed the evidence. Authorities located the alleged murder weapon; a man and his wife were arrested and are awaiting trial. Because of the immediacy and the scope of the investigation, officials required extra computers and processing power to examine incoming evidence. The NTRCFL's computer training room was converted into an examination space, allowing for faster evidence processing.

THREE GUILTY IN CORPORATE HACKING CONSPIRACY: In the first case of its kind in Texas, three Texas men who guit the same company and formed a competing one, were charged in federal court with hacking for the purpose of corporate espionage. Michael Musacchio, CEO of the new company, and two IT employees of the former company, Joseph Roy Brown and John Michael Kelly, were charged with conspiring to steal customers from their former employer. They left a "back door" into the emails of the old company, which then provided access to emails, contracts, business proposals and other documents that were used to compete with their old company for contracts. NTRCFL examiners processed more than 18 TB of evidence in the case, restoring backups of all email, web server logs, virtual machines, Blackberry logs and subjects' desktops. Results showed the subjects had conspired to steal the customers of their previous employer. Revenue from these stolen customers totaled more than \$170 million. Two of the subjects plead guilty; one went trial and was found guilty by the jury.

TEXAS WOMAN CHARGED FOR SENDING RICIN LETTERS TO OFFICIALS: The NTRCFL examined a significant amount of digital evidence submitted in the investigation into the source of poisonous ricin sent in threatening letters to President Obama and other public figures. Shannon Guess Richardson of Texas was named in a three-count

federal grand jury indictment. The charges include threatening the President of the United States and mailing a threatening letters to NY Mayor Michael Bloomberg and Mark Glaze, Director of Mayors Against Illicit Guns. According to press accounts, Richardson tried to frame her estranged husband for the crime by opening a PayPal account and a post office box in his name. The HazMat-qualified NTRCFL examiner decontaminated and imaged the evidence, processed it and then put it onto the CAIR network. Examiners assisted investigators in locating evidence that led to Richardson's arrest. She pleaded guilty in December 2013 and was sentenced to 18 years in federal prison.

CHILD PORNOGRAPHY CASE: The NTRCFL provided digital forensics expertise in a case in which a stepfather is charged with illegally recording his young stepdaughters showering. The children's mother had discovered recordings on the suspect's iPod Touch device, which the subject later threw out of a moving vehicle after claiming that the recordings were likely made by a younger son. Despite not having the device which recorded the videos and photos, NTRCFL examiners located files stored on an Apple MobileSync backup linked to the suspect's user name. EXIF data shows that the videos and photos in question were taken by and iPod Touch. The file paths link the files to the subject.

CHILD EXPLOITATION CASE: Anna Welsh, 31, of Nehalem, Oregon was arrested on multiple charges of sexual misconduct with minors in a case involving two 15-year-old boys during the summer and fall of 2012. The Northwest RCFL provided digital forensics support to the



investigation, cracking the encrypted digital evidence between the suspect and victims. In December 2013, Welsh entered guilty pleas to two non-expugnable Class B felonies in exchange for a 40-month prison sentence and the requirement to register for life as a sex offender. All other charges were dropped as part of the plea deal. The prosecutor said "this is a gender-neutral application of Oregon law."

GUILTY PLEA IN DRUGGING AND SEXUAL ASSAULT CASE:

Marlin Pohlman, 43, a computer technology specialist from North Portland, was sentenced to six years and three months in prison after he pleaded guilty to charges relating to supplying women with drugs and then sexually assaulting them. Press accounts report that one of the victims, who had previously dated the suspect, said that Pohlman enticed her and two other people to his car to inhale nitrous oxide. He then injected her with a drug using a medical syringe. She quickly lost consciousness and was taken to the hospital, where, according to court documents, an attending physician said that she was unconscious for four hours with "a high probability of imminent or life-threatening deterioration." Investigators found a makeshift chemical lab in Pohlman's house. Pohlman pleaded guilty two drug charges, including possessing a large amount of ecstasy, and a third charge of second-degree attempted assault of the victim mentioned above. He pleaded no contest to a fourth charge of second-degree sex abuse. Other charges were dropped as part of the plea bargain. The NWRCFL examiners recovered numerous emails and texts pertinent to the investigation.

PULSE CHECK: STATUS OF FYI3 GOALS

Gain International Accreditation: The NWRCFL completed the ASCLD/LAB International application in preparation for the audit. The audit was postponed until February 2014.

Increase the Number of Participating Agencies: The NWRCFL recruited one new participating agency, however, official confirmation of membership is not expected until FY14.

Expand Certification: The NWRCFL was unable to meet the goal of increasing the number of MAC-light certified examiners because no classes were held during the FY.

Enhance Training: The NWRCFL was unable to meet the goal of hosting UNIX certification training and getting one examiner certified because all advanced courses were canceled this FY due to sequestration.

NOTABLE NEWS

ACHIEVED ASCLD/LAB-INTERNATIONAL ACCREDITATION:

In April 2013, the OCRCFL was approved for the ASCLD/LAB International Accreditation Program in Forensic Science Testing— Digital and Multimedia Evidence-Computer Forensics and Video Analysis.

CO-SPONSORED AMERICAN ACADEMY OF SCIENCES EVENT:

The OCRCFL partnered with the FBI, Los Angeles Division and the National Academy of Sciences, to co-sponsor a Distinctive Voices event on December 14, 2012 at the Beckman Center, Irvine, CA. The half-day program, entitled "Digital Forensics in the 21st Century," featured presentations, case studies, hands-on demonstrations of technology and methods by OCRCFL examiners, and tours of the FBI's state-of-the-art mobile laboratory. More than 280 people attended the program.

GUILTY PLEA IN SEXTORTION CASE:

A Temecula college student, Jared James Abrahams, 19, pleaded guilty to federal charges that he anonymously hacked online accounts and extorted young females in the U.S. and abroad into sending him nude photos and video or submitting to five-minute Skype

Recruit Additional Agencies: The OCRCFL successfully finalized the Memorandum of Understanding with the Los Angeles County Sheriff's Department and the Los Angeles Police Department as participating agencies.



Achieve ASCLD/LAB international Accreditation: The OCRCFL was successfully accredited in the International program on January 13, 2013.



Expand the Use of Training Facility: In the past training had been limited to FBI- sponsored training. During FY13 the OCRCFL's high tech classroom has been used to host computer forensic training offered to local agencies by Microsoft and Apple.



Expand Liaison: The OCRCFL began supporting a new FBI-Los Angeles Division project, "Cyberhood Watch." The program is designed to allow businesses to anonymously submit intrusion and cyber-attack data to the FBI to bolster intelligence. The OCRCFL also initiated liaison with Army Criminal Investigative Division at Fort Irwin, Marine Corps Criminal Investigation Division, the Riverside SAFE and CATCH teams, the San Diego CATCH team and others. As a result, several new agencies are interested in joining the OCRCFL as participating agencies.



Develop New Training: The OCRCFL made plans to create and teach a new technical Prosecutor's Academy class, but scheduling issues prevented the lab from holding the training. It is now planned for FY14.

Abraham would remotely gain control of a victim's computer and then he would demand they provide additional nude photos/video or he would distribute the photos he had secretly recorded of them. The FBI seized computers and hardware, cell phones and hacking software from Abraham's home. OCRCFL examiners recovered photos and videos of the victims, saved video chats, and also texts of extortion demands on both the subject's and victims' computers. They also found evidence consistent with malware and remote administration tools and evidence of online research into ways to spread malware and control webcams.

BOSTON MARATHON BOMBINGS INVESTIGATION: The PHRCFL sent three Forensic Examiners at a time for approximately three weeks conducting imaging and processing of evidence during the initial investigation into the Boston Marathon bombing incident. Two pressure cooker bombs exploded during the Boston Marathon on April 15, 2013, killing 3 people and injuring an estimated 264 others. The initial investigation focused on identifying those responsible and law enforcement asked the public for support. Officials quickly collected record amounts of photographic and video evidence from the hundreds of video surveillance cameras in the crime scene area and thousands of photographs taken by participants and observers that were

submitted for examination.

LAX SHOOTING INVESTIGATION: PHRCFL examiners supported the investigation into shootings at Los Angeles International Airport terminal targeting Transportation Security Administration officers. A gunman opened fire, killing a security screener and wounding three other people. The suspect, originally from Pennsville, N.J., is charged with murder of a federal officer and committing violence at an international airport. The PHRCFL examined cell phones seized in the case. This provided additional leads on possible accomplices.



FROM THE DIRECTOR: The Rocky Mountain RCFL celebrated its seven year anniversary on January 18, 2013. During the past year, our staff has worked very hard to protect the citizens of Colorado and Wyoming by providing investigators first class digital forensics services. Establishing an RCFL requires strong teamwork on the parts of the participating agencies that have joined the program. Our participating agencies have made the RCFL possible.

ACHIEVED ASCLD/LAB-INTERNATIONAL ACCREDITATION: In

2013 the RMRCFL was approved for the ASCLD/LAB-International Accreditation Program in Forensic Science Testing-Digital and Multimedia Evidence-Computer Forensics and Video Analysis. The laboratory had previously achieved ASCLD/LAB Legacy Accreditation in 2008. To be accredited, a laboratory undergoes an intensive assessment by expert evaluators who conduct a wide-ranging assessment. "Accreditation demonstrates that a crime laboratory's management, personnel, quality system, operational and technical procedures, equipment, and physical facilities meet established standards" according to the ASCLD/LAB website. The RMRCFL's Executive Board held a press conference on July 24th to announce this latest achievement. FBI Denver Special Agent in Charge Thomas Ravenelle said: "Today, we celebrate not only our accreditation as one of 43 forensic laboratories in the world to attain international program accreditation... we also celebrate the outstanding partnerships that have made every service provided at this laboratory possible." Douglas County Sheriff David Weaver, the co-chair of the RMRCFL executive board, remarked, "Nearly every crime investigated today involves some type of digital evidence-from a computer, a laptop, a cell phone,

NOTABLE NEWS

ACHIEVED ASCLD/LAB-INTERNATIONAL ACCREDITATION:

During FY13, the San Diego Regional Computer Forensics Laboratory (RCFL) attained International Program accreditation from the American Society of Crime Laboratory Directors' Laboratory Accreditation Board (ASCLD/LAB). The San Diego RCFL's commitment to quality has been unwavering. From its launch, the lab has followed strict quality assurance standards. It attained ASCLD/LAB legacy accreditation in 2008 and is now part of an elite group of forensic laboratories with International Program accreditation.

DIGITAL FORENSICS EXPERTISE HELPS CRACK CASES:

Investigators continue to rely on the expertise at SDRCFL for hundreds of investigations each year. The examples below highlight the SDRCFL's ability to respond quickly to emergency situations and to use advanced forensic techniques.

> Sexual Assault Prosecution: In the first-of-its kind examination by the SDRCFL, an examiner applied advanced cell phone forensics techniques taught and authorized by the FBI's CEAU to successfully recover data from a damaged cell phone. The data was unattainable using standard digital forensics techniques. The cell phone evidence was a deciding factor in the prosecutor's decision to go forward with charges.

PULSE CHECK: STATUS OF FYI3 GOALS



Maintain Quality of Service: The SDRCFL continued to provide timely and high-quality services to its customers during FY13. Downtime for the RCFL move to its new facility was only six calendar days (three work days). Turnaround time for examinations and CAIR reviews were both reduced. Commitment to quality validated by ASCLD/LAB International accreditation.



Promote Training for Law Enforcement Partners in New Facility: The SDRCFL completed the new state-ofthe-art, 24-person, Mac or Windows training room classroom in the new RCFL facility. During FY13 the SDRCFL trained 217 personnel.



Attain ASCLD/LAB international Accreditation: The SDRCFL achieved ASCLD/LAB International Accreditation in September 2013, after a full assessment conducted in February 2013, and a one-day supplemental assessment for the new lab facility following the facility move.



Complete the SDRCFL Move: Successfully completed the move of the SDRCFL to the new facility inside the new San Diego FBI Field Office building during FY13, with only six days of down time. Subsequently completed numerous lab improvement projects and completed new training room.



Continue Service Request Efficiencies: The SDRCFL was very close to meeting its goal of 90% of requests completed within 90 days (at 89%). The CAIR completion time was reduced by one day; the forensic examination time reduced by two days.



Increase Audio/Video Support: Audio/video training was canceled due to FBI program cuts so SDRCFL added no new A/V examiners. However, the SDRCFL's current cadres of trained examiners continued to provide high-quality A/V support, implemented the A/V triage policy, and taught a video recovery course for detectives and provided onsite A/V assistance.

- Guilty Plea in Sexual Assault Case: A subject video recorded a sexual assault on a cell phone and then deleted the file. Standard cell phone forensics could not recover the video, but fragments in unallocated space corroborated the video's existence. The fragment was rebuilt into a lost database record using a script created by a SDRCFL examiner. This revealed additional metadata about the video that helped investigators and led to a guilty plea.
- **Rescue of Kidnapped Teen:** The SDRCFL performed emergency analysis of the computers of a kidnap victim and the subject and provided ongoing results to investigators trying to find the pair. Evidence found gave context to the relationship between the victim and subject. This aided police in the last stages of recovery of the victim.

SHOOTING AND SPORTS CAR **THEFT INVESTIGATION:** Max

Wade, a Marin County teen convicted of a series of crimes that included a gun ambush on a teenage couple and the theft of a celebrity's \$200,000 sports car, was



sentenced to more than 21 years to life in prison. The investigation began on April 13, 2012, when a black-clad motorcyclist opened fire on a pickup truck in Mill Valley. The couple inside the truck, Landon Wahlstrom, 18, and Eva Dedier, 17, ducked and were only slightly injured by flying glass. Marin County sheriff's investigators were able to rapidly identify the suspect as Wade, with the help of SVRCFL, who provided forensic support. During the shooting investigation, authorities discovered that, a year earlier, Wade had stolen a yellow Lamborghini owned by a Food Network celebrity by rappelling into a car dealership and driving off with the car.

BOSTON MARATHON BOMBING INVESTIGATION SUPPORT:

The SVRCFL sent one examiner to Boston to support digital evidence review.

PULSE CHECK: STATUS OF FYI3 GOALS

Provide Remote Network Access to Evidence: The SVRCFL made incremental progress toward this goal, in-spite of limits imposed by sequestration.



Promote Training: The SVRCFL continues to provide evidence review training for participating agencies, and began cellular phone seizure and analysis training for investigators.



Enhance Examiner Capabilities: Examiners earned four advanced certifications, and enhanced skill sets through GETA training, research, and testing.

CONVICTIONS IN TRIPLE HOMICIDE: A federal jury found three defendants guilty of committing a triple murder in the town of Greece, NY on March 9th, 2010. Richard Anderson, Andrew Wright and Aston Johnson were convicted of the murders of three victims-Christopher Green, Robert Moncriffe and Mark Wisdom. The defendants were also convicted of conspiracy drug charges. Three WNYRCFL examiners testified during the 10-week trial. According to evidence presented at trial, the defendants traveled to Rochester from Phoenix and targeted the victims because they believed they were cheating them out of proceeds from the sale of marijuana. Authorities tracked the men across multiple jurisdictions. Federal, state and local law enforcement agencies from New York, Ohio, Arizona and California worked on the investigation, tracking the defendants across multiple jurisdictions. All three subjects were sentenced to life in prison. WNYRCFL assisted with the investigation.

TOYS-R-US MURDER INVESTIGATION: WNYRCFL staff members examined seized phones, computers, and provided video assistance for an investigation into a June 2013 murder in the back office of Hamburg, NY Toys-R-Us store. In October, Bernard Grucza, a regional manager for the toy chain, was arrested and charged with second degree murder for the slaying of assistant store manager, Larry Wells. Grucza pleaded not quilty to those charges. In a plea deal, Grucza later pleaded guilty to first-degree manslaughter.

Complete DCAP Installation: The WNYRCFL completed the installation of the DCAP, the tool that enables state and local agencies to review the results of a forensic examination online in a secure environment rather than needing to travel to the RCFL to review results.



Add to the Ranks: The WNYRCFL began discussion with New York State Department of Taxation and Finance in FY13. The department has committed to participating in the RCFL and will begin in FY14.



Certify New Trainers: FBI Train-the-Trainer classes were canceled due to budget cuts, so no WNYRCFL personnel became certified to teach RCFL classes.

Make Progress Toward ASCLD/LAB Accreditation: Complete ASCLD/LAB accreditation pre-inspection and schedule a full inspection in FY15.



Add One Additional Participating Agency: Recruit at least one new agency to join the WNYRCFL.



Increase Audio/Video Capability: Have one WNYRCFL detailee become certified by the FBI's Forensic Audio, Video and Image Analysis Unit (FAVIAU) as a certified examiner in audio and video disciplines.



Certify New Trainers: Restart the WNYRCFL training programs by having at least one examiner certified to teach classes for RCFL law enforcement customers.
