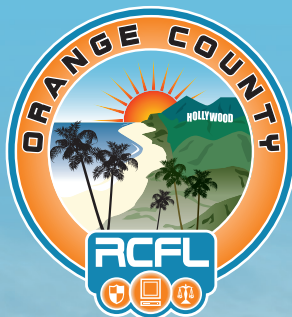

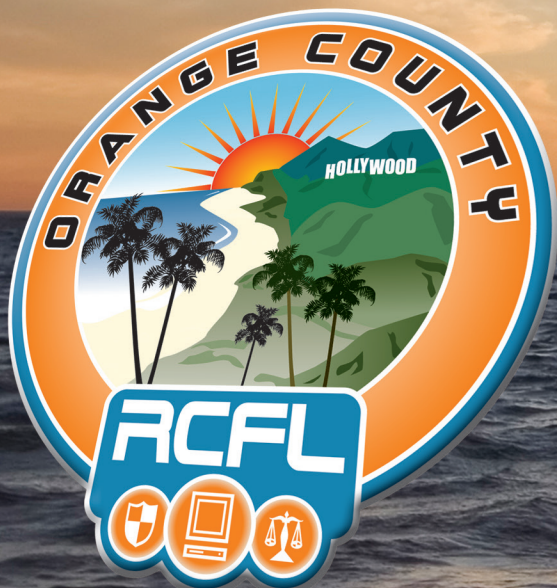

ABOUT RCFLS

A Regional Computer Forensics Laboratory (RCFL) is a full-service forensics laboratory and training center devoted entirely to the examination of digital evidence, in support of criminal and terrorism investigations, such as, but not limited to—

- Homicide
- Child Pornography
- Crimes of Violence
- Theft or Destruction of Intellectual Property
- Internet Crimes
- Fraud.

THE ORANGE COUNTY RCFL

Location—The Orange County RCFL (OCRCFL) is conveniently located in central Orange County.

Service Area—Law enforcement agencies operating within the OCRCFL's seven-county service area are eligible to request assistance. The service area includes all law enforcement agencies within the Central District of California.

Types of Assistance—The OCRCFL offers assistance in the following areas—

- Pre-seizure consultation
- On-site seizure collection
- Duplication, storage, and preservation of digital evidence
- Impartial examinations of digital evidence
- Training
- Courtroom testimony.

BENEFITS OF PARTICIPATION

The RCFL Program brings together regional law enforcement officials from federal, state, and local government agencies. Known as “Participating Agencies,” these organizations enter into a Memorandum of Understanding with the FBI and then assign staff to the RCFL and pay their normal salaries and benefits. Benefits to an agency include—

- Requests for service are given top priority.
- Costs are reduced—joining an RCFL is far less expensive than building and equipping a computer forensics laboratory.
- The FBI funds the training and certification of all RCFL Computer Forensics Examiners.
- The agency gains a seat on the Local Executive Board and voting rights.
- With strict quality assurance protocols and procedures in place, the highest level of service is guaranteed.

BENEFITS TO RCFL STAFF

Benefits to an individual assigned to an RCFL include—

- Approximately 7 weeks of first-class technical training
- The opportunity to earn certification from the FBI's Computer Analysis Response Team as a Computer Forensics Examiner
- A suite of forensics equipment and software
- Direct Peer Review and coaching from FBI-certified Examiners
- Overtime compensation
- Use of a cellular telephone and vehicle while on duty
- A “Top Secret” security clearance—enabling RCFL Examiners to work on a variety of investigations.
